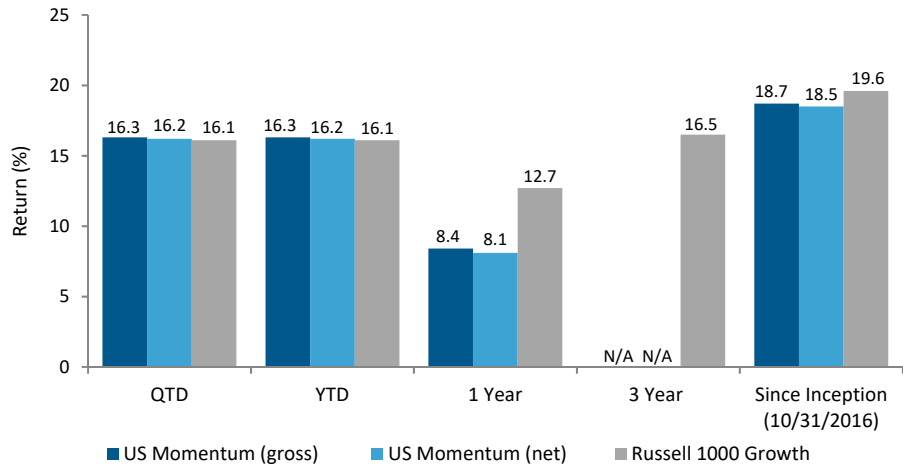

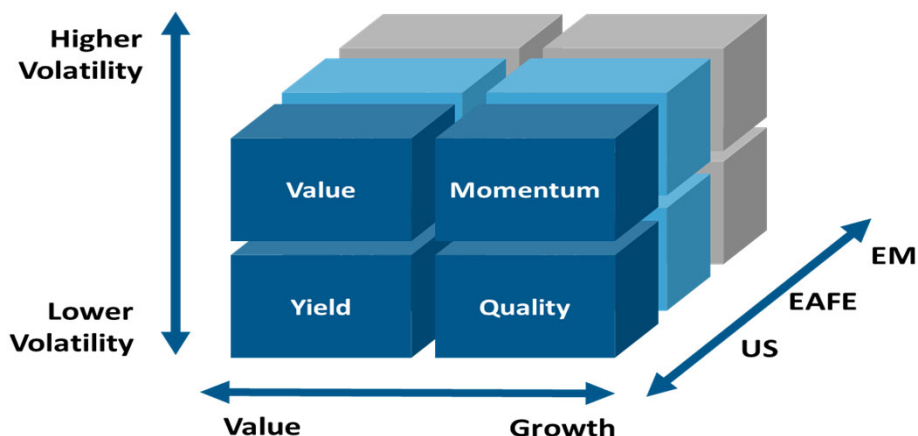

Cadence manages domestic and international equities for institutional investors using rules-based strategies with periodic rebalancing. Cadence also acts as sub-advisor for several mutual funds. In November 2010, Cadence acquired a long/short domestic equity hedge fund and a long-only SMIDCap fund. Since March 31, 2014 these assets have been included in the definition of the firm for the purposes of GIPS presentations and verifications. Effective April 1, 2016, the SMIDCap fund has been closed, and Cadence consolidated the assets of the two private funds. Effective September 1, 2017, the hedge fund has been closed. The Cadence Composites are constructed of similarly managed, unconstrained, discretionary accounts in accordance with industry calculation standards. New accounts are included in their first full calendar month of operation. Performance is based on time-weighted, total returns including resigned accounts. Performance results reflect the reinvestment of dividends and other earnings. Valuations and returns are computed and stated in US dollars on a trade date basis. Composite Characteristics:

The U.S. Momentum Composite was created in October 2016 and has an inception date of October 31, 2016. A complete list and description of all firm composites is available upon request. Accounts in the U.S. Momentum Composite have an initial universe comprised of stocks within the Russell 1000 index. This composite is constructed of similarly managed, unconstrained, discretionary accounts in accordance with industry standards, and is a rules-based portfolio that is rebalanced periodically and typically holds between 200-350 securities.

Stocks in the U.S. Momentum portfolio must exhibit relatively strong fundamental and price performance. Stocks in the U.S. Momentum portfolio must pass liquidity screens. New accounts that fit the composite definition are added at the beginning of the first full calendar month for which the account is under management. Closed account data is included in the composite as mandated by the standards in order to eliminate a survivorship bias. U.S. Momentum restricted accounts (e.g., "sin-free" accounts) are not included in this composite. The primary composite benchmark is the Russell 1000 Growth index.

Benchmark Definition:

The Russell 1000 Growth index measures the performance of the large-cap growth segment of the U.S. equity universe. It includes those Russell 1000 companies with higher price-to-book ratios and higher forecasted growth values. The benchmark returns are not covered by the report of independent verifiers.
